A tenure position will be granted on the basis of multiple aspects such as education, research, campus activities, and the social contributions of an applicant.

3. Field of Study

English education or related major

4. Duties

1) Teaching English (Academic English) and related courses (day and evening classes possible), Graduate School Classes (all faculty members are responsible for general education classes and evening classes.)

2) Research in the area of English Education or a related field.

5. Qualifications

1) An early career researcher with a PhD in English Education or related field.

2) Enthusiasm for and demonstrated capacity to participate actively in the development of the English Education program at NITech; ability to cooperate with faculty and staff; ability to provide university English education utilizing e-learning and generative AI; ability to participate in the making of entrance exams, university administration, the overseas internship program and all other activities related to operation of the university.

3) Ability to be actively involved in the Faculty Development activities of the university.

4) An adequate command of Japanese to manage daily university work.

5) Experience teaching English at a tertiary institution is desirable.

6. Salary and Benefits will be determined according to the university regulations.

Annual salary system will be applied.

7. Starting date: April 1, 2026, or the earliest possible date thereafter.

8. Application Materials

1) A full statement of Curriculum vitae (with photo). Include a complete list of academic achievements, work experience, membership in academic organizations, social and volunteer activities. Include email and contact information.

- 2) A list of academic publications and presentations (books, reviews, journal articles, international journal articles, speeches, presentations, patents, and any other relevant information.)
- 3) Summaries of 3 representative publications.
- 4) A history of obtaining external funding (Grants-in-Aid for Scientific Research, Contract Research Funds, Joint Research Funds, Scholarship Donations, Research Grants, etc. Include the name of the fund, the year, the research theme, the amount, and distinguish between the leader researcher and participant researcher).
- 5) A summary of research to date and a plan for future research (2,000 Japanese characters).
- 6) An explanation of your philosophy of teaching English. Include information regarding teaching English to engineering students (2,000 Japanese characters).
- 7) Two references: contact information, current affiliation, and information regarding the relationship of the reference to the candidate.
