

Guidelines on the Treatment of Subsidies Related to the Commercialization of Nagoya Institute of Technology's Research Assets based on Nagoya Institute of Technology Foundations

Established on August 5, 2009

(Objective)

1. These guidelines, based on the Provisions of Article 8 of the Nagoya Institute of Technology Rules on Funds (established on March 26, 2008), shall define the necessary matters concerning Subsidies Related to the Commercialization of Nagoya Institute of Technology's Research Assets based on Nagoya Institute of Technology Foundations (hereinafter, "Subsidies for Commercialization").

(Purpose)

2. Subsidies for Commercialization are aimed at revitalizing the educational research activities of the Institute and contributing to society by subsidizing rental and other fees for facilities outside the Institute necessary for faculty members and students of Nagoya Institute of Technology (hereinafter, "the Institute") to engage in such commercialization based on patents held by the Institute.

(Project)

3. Subsidies for Commercialization are intended for the project to subsidize rental and other fees of facilities outside the Institute for faculty members and students of the Institute.

(Expenses of the Project)

4. Necessary expenses to carry out the project stipulated in 3 shall be appropriated with the funds of Nagoya Institute of Technology.

(Year of the Project)

5. The year of the project shall begin on April 1, and end on March 31.

(Period of Subsidies)

6. The period of subsidies shall be within one year.

(Eligibility for Applicants)

7. Those listed in the items below who are involved in commercialization based on patents whose rights are held by the Institute shall be able to apply for Subsidies for Commercialization.
 - (1) Full-time Professors, Associate Professors, Assistant Professors, and assistants of the Institute
 - (2) Students who are enrolled in the Faculty of Engineering and the Graduate School of Engineering of the Institute

(Amount of Subsidies)

8. The total amount of rental fees for facilities outside the Institute shall not exceed 2,000,000 yen.

(No. of Subsidy Cases)

9. Subsidies for Commercialization shall be limited to two cases per fiscal year in principle.

(Applications)

10. Those who apply for Subsidies for Commercialization must submit the separately prescribed application form for Subsidies for Commercialization to the Director of Social Contribution and Collaboration Office.

(Reviewing)

11. Applications shall be screened by the Promotion Council of the Nagoya Institute of Technology Center for Social Contribution and Collaboration based on the submitted documents.

(Administrative Matters)

12. Administrative matters related to Subsidies for Commercialization shall be conducted at the Research Support Division.

(Miscellaneous Provisions)

13. Necessary matters concerning Subsidies for Commercialization outside these Guidelines shall be defined separately.

Supplementary Provisions

These guidelines shall be put into effect on August 5, 2009.

Supplementary Provisions

These guidelines shall be put into effect on August 1, 2012.
