Nagoya Institute of Technology Regulations on the Completion of Curricula over an Extended

Term

Established on April 1, 2004

(Purpose)

Article 1 These regulations shall define necessary matters on the Completion of Curricula over an Extended Term based on the Regulations of Clause 2, Article 25 of the Nagoya Institute of Technology Rules (Established on April 1, 2004. Hereinafter, "the Rules"), and of Article 46 of the Nagoya Institute of Technology Graduate School Rules (Established on April 1, 2004. Hereinafter, "the Graduate School Rules").

(Qualifications for Application)

- **Article 2** Those who can apply for the completion of curricula over an extended term shall be mature students (incl. prospective new students) and students with physical or mental disabilities, except for students in the final year of completion.
- 2 "Students with physical or mental disabilities" as used in the preceding paragraph refers to those students specified in Article 2, Item 1 of the Nagoya Institute of Technology Staff Guidelines for Eliminating Disability-Based Discrimination (enacted March 24, 2016) who are receiving reasonable accommodation under Article 7, Item 1 of the same guidelines.

(Submission of the Application Form for and Plan of the Completion of Curricula over an Extended Term)

Article 3 Students who apply for the completion of curricula over an extended term shall submit the application form for and plan of the completion of curricula over an extended term, which are defined separately, to the President within the prescribed period after obtaining the consent of their Heads of Department, Course, Graduate School Department, or Program (hereafter "Heads of Department").

(Approval of Completion of Curricula over an Extended Term)

Article 4 The President shall approve cases of the completion of curricula over an extended Term through deliberation at the Educational Affairs Committee (hereinafter, "the Committee").

(Time to Take Curricula over an Extended Term)

Article 5 The time to take curricula over an extended term for students who had their application for the completion of curricula in longer term accepted (hereinafter, "Students with Extended Term of Completion of Curricula") shall be the beginning of the year.

(Setting of the Period to Complete a Curriculum)

Article 6 The period to complete the curriculum for students with extended term of completion of curricula shall be within the period twice the duration of studies stipulated in Article 11 of the Rules and the Standard Duration of Studies stipulated in Article 8 of the Graduate School Rules.

(Changes in the Period to Complete a Curriculum)

- **Article 7** When changing their period to complete the curriculum, which was initially approved, students with extended term of completion of curricula shall submit the application form for and plan of changing the completion of curricula over an extended term, which are defined separately, to the President within the prescribed period after obtaining the consent of their Heads of Department, Program, or Graduate School Department.
- **Article 8** The President shall approve the changes in the period to complete the curriculum through deliberation of the Board.

(Miscellaneous Provisions)

Article 9 Necessary matters concerning the treatment of the completion of curricula over an extended term other than matters stipulated in these regulations shall be defined separately.

Supplementary Provisions

These Regulations shall be enacted on April 1, 2004.

Supplementary Provision (Rules No. 21, March 2, 2016)

These Rules shall come into effect on April 1, 2016.

Supplementary Provision (Rules No. 25, March 11, 2019)

These Rules shall come into effect on April 1, 2019.

Supplementary Provision (Rules No. 31, February 19, 2020)

These Rules shall come into effect on April 1, 2020.
